NOTES ON APPLICATION FOR EXTENSION OF DURATION OF A PERMISSION

- (1) In accordance with the Planning and Development Regulations 2001 (as amended), the following requirements apply:-
 - (a) An application to extend the Duration of a Permission may not be made earlier than one year before that Permission is due to expire.
 - (b) An application for an Extension of Duration can be entertained only where:
 - (i) the development to which the Permission relates has commenced;
 - (ii) substantial works have been/will be carried out before the expiry date of the permission;
 - (iii) the development will be completed within a reasonable time; and
 - (iv) the application to extend the Duration of the Permission is made before the expiry date of the Permission.
 - (c) Where a proper and complete application is received, a decision must be conveyed to the applicant within eight (8) weeks except where additional necessary information is required.
- (2) The Planning and Development Regulations 2001 prescribe a fee in respect of all applications for Extension of Duration. **THE AMOUNT OF THE FEE IS CURRENTLY €62-00.**
- (3) Query No. 11 on the application form should be replied to very carefully as the applicant's right to an extension is decided chiefly on the amount of works actually done at the expire date.
- (4) All queries on the form must be completed and the form must be accompanied by the relevant fee.
- (5) Query's no 15 & 16 on the application form should be replied to very carefully as the applicant's right to a further extension is decided on these details.

N.B. These notes are intended for the guidance of applicants only and do not purport to be a legal interpretation of the various Acts and Regulations referred to.
